

50 Commonly Missed Tax Deductions (2023 Tax Year)

Home Ownership

- Did you pay mortgage interest on your main home or second home? (YES / NO)
- 2. Did you pay interest on RV or Boat loan (that has sleeping, cooking and bathroom facilities)? (YES / NO)
- Did you pay real estate taxes on your main home? (YES / NO)
- 4. Did you pay real estate taxes on any other homes and land? (YES / NO)
- Did you pay loan origination fees (i.e. points) on a mortgage or refinance? (YES / NO)
- Did you pay interest on a home equity loan and use the proceeds to improve your home? (YES / NO)
- 7. Did you make energy efficient home improvements such as solar power, HVAC, or insulation? (YES / NO)
- 8. Did you renovate or add on to your home (new floors, fence, countertops etc.)? (YES / NO)
- Did you purchase a mobile or manufactured home? (YES / NO)

Charitable Contributions
